

ARTICLES OF INCORPORATION OPEN DOOR BAPTIST MISSION, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Horida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be OPEN DOOR BAPTIST MISSION, and the proposed place of business shall be P. O. Box 7000846, St. Cloud, Florida 347770.

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.

ARTICLE III

The purpose for which the corporation is organized is as follows:

To operate a Christian Church and to conduct such other business as may reasonably be related to said operation.

ARTICLE IV

The qualifications for members are that they must be born again Christians.

ARTICLE V

The number constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve initially are:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in §501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.
