ARTICLES OF INCORPORATION

OP

BEHT OAKS OF WASHINGTON COUNTY HOMEOWNERS' ASSOCIATION, INC.

We, the undersigned acting as incorporators of a non-profit corporation under Chapter 617 of the Florida Statues, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME -- The name of this corporation is BENT OAKS OF WASHINGTON COUNTY HOMEOWNERS' ASSOCIATION, INC.

ARTICLE II

PURPOSE -- This corporation is organized to further promote the common interest of property owners in the area known as BENT OAKS, and specifically described in Exhibit "A" attached hereto. In furtherance of this purpose, this corporation may exercise all powers and privileges set forth in the Bent Oaks Protective Covenants as recorded in Official Records Bock 245, pages 985 - 999, of the public records of Washington County, Florida, as it may be amended from time to time. DURATION -- The period of duration of this Association shall be perpetual.
