ARTICLE ONE

Name

The name of the Corporation is AFRICAN AMERICAN CHAMBER OF COMMERCE OF VOLUSIA AND FLAGLER COUNTIES, INC

ARTICLE TWO

Principal Office and Address

The address of the principal office of the corporation is 333 South Ridgewood Avenue, Daytona Beach, Florida 32114 and the mailing address of the corporation is the same

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State Florida.

ARTICLE FOUR

Purpose

The Corporation is organized to advance the general welfare and prosperity of African American businesses in the Volusia and Flagler counties so that all citizens in these communities shall prosper. All necessary means of promotion shall be provided and particular attention and emphasis shall be given to the economic, civil, commercial, industrial and educational interests of African American businesses in these areas

ARTICLE FIVE

Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation

ARTICLE NINE
Distribution of Assets

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(6) of the Internal Revenue Code of 1986, or a corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not disposed of by a Court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.


