ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of the Incorporation for such corporation:

ARTICLE I. CORPORATION NAME, PRINCIPAL OFFICE & MAILING ADDRESS

The name of this corporation is GENDERED MEDIA, INC.

ARTICLE II. GENERAL AND SPECIFIC PURPOSES

This is a corporation not-for-profit, organized solely for general educational purposes pursuant to the Florida Corporations Not for Profit Law, set forth in Section 617 of the Florida Statutes

The term of existence of the corporation is perpetual

The qualifications for members and the manner of their admission by the corporation shall be regulated by the corporation's by-laws
