ARTICLES OF INCORPORATION

The undersigned, acting as incorporator pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

ARTICLE II

Principal place of business and mailing address

ARTICLE III

Purpose

The specific purpose for which the corporation is organized is:

THE CORPORATION IS FORMED EXCLUSIVELY FOR RELIGIOUS, CHARITABLE, SCIENTIFIC, LITERARY AND EDUCATIONAL PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE OF 1986, AS AMENDED AND IN EFFECT ("THE CODE").

WITHOUT LIMITING THE FOREGOING, THE CORPORATION'S PURPOSE SHALL INCLUDE THE OPERATION OF FACILITIES TO FURTHER AND ENHANCE THE RECOVERY OF ADDICTS.

ARTICLE IV

Manner of election of directors.

The manner in which the directors are elected or appointed shall be provided in the By-Laws. The number of Directors shall be fixed from time to time as provided in the By-Laws but shall not be less than three. ARTICLE V

Limitation of Corporate Powers

The corporation powers of this corporation are as proved in section 617.0302, Florida Statutes, unless limited as follows:

LIMITATION ON ACTIVITIES

- 1. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) a campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c) (3) of the Code (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Code (or the corresponding provision of any future United States Internal Revenue law).
- In the event the Corporation shall be classified as a private foundation under the Code, the Corporation shall: (1) expend or distribute for its exempt purposes, the income of the Corporation for each taxable year, at such time and in such manner as not to subject the Corporation to tax under Section 4942 of the Code; (ii) not engage in any act of self-dealing, as defined in Section 4941 (d) of the Code; (iii) not retain any excess business holdings, as defined in Section 4943(c) of the Code; (iv) not make any investment in such manner as to subject the corporation to tax under Section 4944 of the Code; and (v) not make any taxable expenditures, as defined in Section 4945 (d) of this Code. For purposes of this paragraph, references to specific sections of the Code also shall be deemed to apply to any corresponding provision of any future United States Internal Revenue law.

DISTRIBUTION OF INCOME

This corporation shall not have or issue shares of stock. No dividends shall be paid and no part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article III hereof.

DISSOLUTION

In the event of liquidation and dissolution of the Corporation for any reason, the assets remaining after payment of all debts, liabilities and obligations of the Corporation shall be distributed or be disposed of by the Board of Directors exclusively in accordance with the purposes of the Corporation, in such manner and to such organization or organizations, organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Code (or the corresponding provision of any future United States Internal Revenue law) as the Board of Directors shall determine.
