**ARTICLES OF INCORPORATION
501(c) (3)
A Florida Corporation**

WE, the undersigned, having come together in brotherly love, being on one accord, and in full knowledge of the duties and responsibilities therein subscribed, and have associated ourselves together to form a Non-Profit Corporation, for charitable, philanthropic and religious purposes, under the Laws of the State of Florida, and do make and subscribe, acknowledge and file the following Articles:

ARTICLE I

The name of this corporation shall be **I AM YOUR HELPING HANDS, INC.**, The address shall be: 3781 N.W. 191st Street, Miami, Florida 33055.

ARTICLE II

Specific and Primary Purpose

The specific and primary purpose for which the Corporation is being formed is to Minister equally to the spiritual, moral, and social needs of all mankind, regardless of race, creed, sex, color, or culture.

ARTICLE III

Secondary and General Purposes

This Corporation is one organized under and pursuant to the general Non-profit Corporation of the Laws of the State of Florida and is organized for the purposes set out above and its object, purposes and powers are further defined as follows:

- A. To acquire and maintain by purchase, lease, gift, device, or otherwise all kinds and classes of real, personal, or mixed property. To use and apply the whole or any part of the income, therefrom and the principal thereof, exclusively for charitable, religious, scientific, literacy, and educational purposes.
- B. To do any and all things needful and necessary to be done, which are lawful, in connection with the above listed.
- C. To borrow money in such amounts and for such periods of time and upon such terms and conditions as may be considered for

the best interest of the Corporation, and to make, execute and deliver such promissory notes, bonds, and other evidence of indebtedness, with or without security, (including the insurance of script) and make, execute and deliver all necessary, proper or required deeds, conveyances, mortgages, or other instruments securing the payment of the said indebtedness.

- D. To receive gifts and donations of property and money for the purposes and uses of the Corporation. Notwithstanding the above statements and powers, the organization will not engage in any activities which are not in furtherance of the primary purposes.

ARTICLE IV

Non-Profit Corporation

The Corporation shall be one which does not contemplate pecuniary gain or profit to the members thereof, nor the distributions of the net earnings of the association shall inure to the benefit of any of its members or any other private individual.

In the event of the Dissolution of the Corporation, after paying adequately for its debts and obligations, the Board of Directors shall devote any remaining assets of the Corporation to carry out one or more of the purposes of the organization, if feasible and if not, the Corporations's net assets shall be distributed to any one or more non-profit fund foundation, corporation, associations organized and operated solely for charitable, religious, scientific, educational, or other eleemosynary purposes, and which have established their tax exempt statues under Section 501(c)(3) of the Internal Revenue Code, and of this Corporation holds assets in trust, such assets shall be disposed of in accordance with the Non-Profit Corporation Law of the State of Florida.

ARTICLE V

Principle Office

The principle office for the transaction of the business of this Corporation shall be located in the County of Dade, State of Florida. The initial business address of the Corporation shall be: **3781 N.W. 191st Street, Miami, Florida 33055**. The name of the registered agent at such address is: Robbin Farrington.

ARTICLE VI

Term

The existence of this Corporation shall be perpetual.

ARTICLE VII
