# ARTICLES OF INCORPORATION

OF

FONDATION DE RECHERCHES SUBAQUATIQUES

ET

#### ATMOSPHERIQUES. INC.

THE UNDERSIGNED, acting as incorporator, for the purpose of forming a not for profit corporation, hereby makes, subscribes, acknowledges, and files the following Articles of Incorporation in accordance with the laws of the State of Florida, not for profit Statues under chapter 617.

#### ARTICLE I

The Name of this corporation shall be:

"FONDATION DE RECHERCHES SUBAQUATIQUES ET ATMOSPHERIQUES, INC."

#### ARTICLE 11

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State of Florida, and shall have perpetual existence.

#### ARTICLE III

The principal place of business and the mailing address of this corporation shall be:

1010 N.W. 11th Avenue Miami, Florida 33136

#### ARTICLE IV

# PURPOSE

1). The general purposes for which this corporation is formed are to operate exclusively for such charitable puposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenu Code of 1954 or corresponding provisions of any subsequent Federal tax laws, including, for such purposes, the making of distributions to organizations qualifying as

tax-exempt organizations under the Code.

- 2). The specific purposes for which this coporation is formed are to plan, initiate, develop, oversee, support, help coordinate and manage Educational Marine, Atmospheric programs and resources for the people of Haiti, and to support the development of an independent comprehensive aquatic and atmospheric Science Center.
- 3). To receive any gift, bequest, devise, grant or in any other manner, money, assistance or any other form of contribution, or any type of property whatsoever, from any person, organization, governmental agency, or other entity and to otherwise acquire, in every lawful manner, money, securities, property rights and services of every kind and description, and to hold, invest, spend, use or otherwise dispose of all such acquisitions for the purpose of the corporation.
- 4). This corporation shall not, as a substantial part of its activities, carry out propagnada or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.
- 5). Except as limited by these Articles of Incorporation or its Bylaws, the corporation shall have and exercise all rights and powers in furtherance of its purposes as are now or may hereafter be conferred on not-for-profit corporations under the laws of the State of Florida.

#### ARTICLE V

#### POWERS

Except as limited by these Articles of Incorporation or its Bylaws, the Corporation shall have and exercise all rights and powers in furtherance of its purposes as are now or may hereafter be conferred on not-for-profit corporations under the laws of the State of Florida.

Without limiting the generality of the powers specified above, the specific powers of the Corporation shall be:

- a) To raise funds, including grant seeking, in order to support, expand, enhance, sustain or maintain the activities of the corporation or any of its affiliated organizations;
- b) To procure and acquire, by donation, purchase, lease or otherwise, and hold control to the above mentioned

assets as may be beneficial to the fulfillment of the charitable, scientific, and educational purposes of FONDATION DE RECHERCHES SUBAQUATIQUES ET ATMOSPHERIQUES, INC. and other affiliated organizations;

- c) To make charitable contributions to any affiliated organizations;
- d) To manage and operate any of its assets or the assets of others in recognition and attainment of the foregoing objectives; and
- e) To utilize its income in furtherance of the foregoing objectives.

# ARTICLE VI

#### LIMITATIONS ON ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any Member, Director or Officer of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no Member, Director or Officer of the corporation, or any other private individual, shall be entitled to share in the distribution or any of the corporate assets on dissolution of the corporation, provided, however, the corporation may confer benefits in the form of distributions, in dissolution otherwise, upon a not-for-profit corporate member described in Section 501 (3) (c) of the Code. No substantial part of the activities of the corporation shall be the carrying on of the propaganda or otherwise attempting to influence legislation, the corporation shall not participate in or intervene in any political campaign (including the publication or distribution of Statements) on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt for taxation under Section 501 (c) (3) of the Code or other applicable codes, or by an organization contributions to which are deductible under Section 170 (c) (2) of the Code.

### ARTICLE VII

#### CONDUCT OF AFFAIRS

The business and affairs of this Corporation shall be conducted in a manner consistent with a not for profit organization, within all applicable provision of the Articles of

Incorporation and Bylaws of this corporation.

#### ARTICLE VIII

#### BOARD OF DIRECTORS

The business of the corporation shall be managed by a Board of Directors, the exact number to be determined from time to time in accordance with the Bylaws. The Directors shall be elected as stated in the Bylaws.

Number on Committee: The initial Board of Directors shall be composed of three (3) members. The exact number of these members shall be specified from time to time in the By-laws of the Corporation but shall not be less than three (3). Whenever the By-laws fail to specify the exact number, the number of individuals on the Board shall be a minimum of three (3).
