ARTICLES OF INCORPORATION

6/10/96 The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617. Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE 1

Name: The name of the Corporation is: THE FARRINGTON FOUNDATION, INC.

ARTICLE 11

Principal place of Business: The principal place of business and mailing address will be:

ARTICLE III

Purpose: The specific purposes for which the Corporation have been organized are the following:

- (A) To carry on and engage in any and all non profit activity as is now or at any time in the future permitted by the State of Florida and the U.S.A. and its territories and protectorates.
- (B) The primary purpose of the Corporation is to operate as a nonprofit corporation and engage in activity that:
 - Identifies, funds and solves worldwide environmental issues through an educational process involving mass communication. The primary environmental areas will be global warming, air pollution, water pollution and the greenhouse effect
 - Supplies, on a worldwide basis, the energy needed for irrigation and the equipment needed for agriculture
 - Aides in the enforcement of environmental protection worldwide
 - Combats overpopulation problems by supplying low cost energy to third world countries. This low cost energy will be used in a way that can: educate the populace into learning about overpopulation, and educate the populace into learning farming and agricultural procedures, which will enable the people to feed themselves.
 - Fosters science education and research
 - Improves human services

ARTICLE IV

Manner of election of Directors: The manner in which Directors are elected or appointed is stated in the bylaws of the Corporation

ARTICLE .

Limitation of Corporate Powers and Specific Guidelines:

- (1) The Corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes except as follows: The Corporation can make donations for the public welfare or for for charitable, scientific, educational or other similar purposes. The Corporation cannot make donations for religious purposes.
- (2) Any individual coming to this Foundation for the purpose of receiving any benefit from it is bound by the following quidelines:
 - In any and all cases, anyone in the U.S.A. needing assistance must be a citizen of the U.S.A. or a legal alien.
 - Legal aliens regardless of nationality or culture, who apply for benefits from the Foundation and have lived in the United States over a three year period must apply for U.S. citizenship. The Foundation may assist in the citizenship application process.
 - Any American citizen over 18 must be registered to vote and possess a valid voter registration card.
 - Anyone gaining any benefit from this Foundation who is able to work, desirous of work or can be educated to work, must work while he or she is enjoying any benefit from this Foundation. The Foundation may provide employment assistance to these individuals preferably in an environmental field. Allowances will be made in this area for the ill, the handicapped and single parent families.
 - Anyone coming to the Foundation for the purpose of receiving any benefit from it will be required to take a drug test
- (3) The Foundation will not be allowed to fund any athletic or sporting event of any kind whatsoever.
- (4) The foundation will not be allowed to support an arts and entertainment (A&E) event unless an assigned committee of the Foundation has given their approval. Very specific guidelines are established in the bylaws for funding A&E events.
- (5) The Foundation will not be allowed to solicit funds but may accept particular contributions from time to time as approved by the Board of Directors
