ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

The purpose of this organization is to provide a written set of guide lines forwhich our community can co-habitate. We can collect funds annually for planned social events and beautification projects for the common areas of the development. And we can work in conjunction with the city to help keep our area clean and crime free.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

As stipulated in the bylaws, there will be one vote per household in the election of all directors. There are 34 homes in the community. Each home must vote either in person by a show of hands or in written form and presented to the Secretary prior to the meeting. Majority rules in all voting venues. A written notice will be sent to each home two weeks prior to each meeting.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes. unless limited are as follows:

This corporation and its officers have the power to enforce any and all laws written either by State, City or in the bylaws of this corporation. To ammend any bylaws a meeting must be announced in writting two weeks prior to the event. A vote must be recorded by all 34 homes and the majority ruling will constitute a decision.
