OF

Pursuant to the provisions of Section 617.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

ARTICLE I - NAME OF CORPORATION

The name of the corporation is SPYGLASS MEDICAL DISTRICT ASSOCIATION, INC. (hereinafter referred to as the "Corporation").
