**ARTICLES OF INCORPORATION  
OF  
SAGE Services, Inc.**

The undersigned, acting as incorporator of SAGE Services, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be: **SAGE Services, Inc.**

**ARTICLE II. ADDRESS**

**ARTICLE III. PURPOSE**

The purposes for which SAGE Services, Inc. is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

**ARTICLE IV. ELECTION OF DIRECTORS**

The corporation shall have four directors initially, elected as outlined in the bylaws of SAGE Services, Inc. The number of directors may be either increased or diminished from time to time, as provided in the bylaws, but shall never be less than one.
