We, the undersigned, with other persons being desirous of forming a corporation for charitable purposes under the provisions of Chapter 617 of Florida Statutes, do agree to the following:

# ARTICLE I. NAME

The name of this corporation shall be Apprinticeship Council of Trades, Inc. with its Principal Office located at 94 Second Street So., Naples, FL 33940-5909 or as may be later designated by the Board of Directors.

# ARTICLE II. DURATION

The term of existence of the corporation is perpetual.

# ARTICLE XI. NON-PROFIT STATUS

No part of the net earnings of the Corporation shall inure to the benefit of any individual or member.

# ARTICLE XII. DISTRIBUTION OF ASSETS UPON DISSOLUTION

No person, firm or Corporation shall ever receive any dividends or profits from the undertaking of this Corporation. Upon dissolution of this Corporation, all of its assets remaining after payment of all cost and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code, or to the federal government, or to a state or local government, for a public purpose, and none of the assets will be distributed to any member, officer, director or trustee of this Corporation.

# ARTICLE XIII. DUES

The amount of the yearly dues payable by members of this Corporation shall be such amounts as may be determined from time to time by the Board of Directors and set forth in the By-Laws.

# ARTICLE XIV. POWERS

In order to promote the purposes of this Corporation, it may acquire property by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the objects of the Corporation shall require and not for pecuniary profit.
