ARTICLES OF INCORPORATION

OF

NEW LIFE CHILD DEVELOPMENT CENTER, INC. (A Florida Not for Profit Corporation)

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statues, do agree to the following:

ARTICLE I.

The name of this corporation is:

NEW LIFE CHILD DEVELOPMENT CENTER, INC.

The principal place of business of this corporation shall be 1536 44th Street, West Palm Beach, FL 33407, and the mailing address of the corporation shall be the same.

ARTICLE II.

This corporation is organized not for profit under the laws of the State of Florida for such purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent Federal tax laws, including for such purposes, the making of distributions to organizations which would qualify as tax exempt under the code.

ARTICLE III.

Within the scope of the foregoing the corporation is specifically organized to:

- a. To acquire, improve and operate any real or personal property or interest of right herein or pertinent hereto;
 - b. To sell, convey, assign, mortgage, and lease real and personal property;

c. To borrow money and execute such documents of evidence such as contracts agreements and instruments in carrying out the foregoing purposes and powers.
