**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **Help Us Save The Florida Keys, Inc.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is 608 Whitehead Street, Key West, Florida 33040.

**ARTICLE III: PURPOSE**

To provide information to the public regarding the proposed Management Plan for the Florida Keys National Marine Sanctuary.

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

## **ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office and agent of the corporation is David Paul Horan, 608 Whitehead Street, Key West, Florida 33040.

## **ARTICLE VI: INITIAL BOARD OF DIRECTORS**

The number of persons constituting the Board of Directors of the corporation is initially three. The manner in which the directors are elected is stated in the corporate bylaws. The name and address of each person who is to serve as a member of the initial Board of Directors is

## **ARTICLE VIII: DISSOLUTION**

## **ARTICLE X: AMENDMENTS**


The corporation reserve the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
