ARTICLES OF INCORPORATION
FOR
THE ALLIANCE FOR HOLISTIC HEALING, INC.

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: THE ALLIANCE FOR HOLISTIC HEALING, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of this corporation shall be: 7766 Bay Street, Suite 11, Sebastian, Florida 32958, and the mailing address shall be P.O. Box 361815, Melbourne, Florida 32936.

ARTICLE III GENERAL AND SPECIFIC PURPOSES

(a) The specific purposes for which this corporation is formed are to encourage and support health care practitioners in their personal practices and organizations by networking, sharing resources and training, and being inspired by speakers and writers who model holistic healing; to join together and use the power of the group to serve as a valuable resource, educate and expand awareness about holistic healing in our communities, institutions, and with fellow healers; and to promote social transformation towards holistic healing by encouraging the creation of like-minded groups throughout the state and country and networking with them, and participating in national forums and publications.

(b) The general purposes for which this corporation is formed are to operate exclusively for such charitable, scientific and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

(c) This corporation shall not, as a substantial part of its activities, by propaganda, lobbying, or otherwise, attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE VIII DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to scientific, charitable and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any trustee, director, officer, or member of this corporation, or to the benefit of any private individual.

ARTICLE IX DISTRIBUTION OF ASSETS

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, scientific or educational

purposes, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws, and which embodies a similar purpose and membership make-up; specifically, a group of healthcare and helping practitioners dedicated to mind, body, spirit (holistic) approaches in the sound practice of medicine and healing, who promote these concepts and share experiences via educational formats and community education vehicles.
