### ARTICLE I

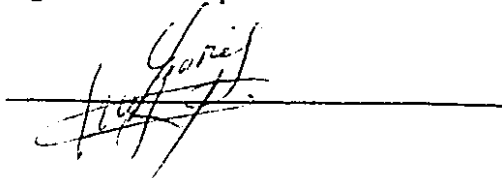
