**ARTICLES OF INCORPORATION
OF**

BUSTAMANTE PATRONAGE INC

(A State of Florida not for profit organization)

ARTICLE I - NAME

The name of the organization is **BUSTAMANTE PATRONAGE INC.**

ARTICLE II - DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III - PURPOSE

The purpose for which this organization is organized is exclusively religious, charitable, scientific, literary and educational, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law.

Furthermore, the purpose of this organization shall be to solicit and accept contributions, by whatever legal means may be available, in order to provide funds for the education, nourishment, and human development of children of poor families in Florida, the Caribbean Islands, Mexico, and Central America.

Notwithstanding any other provision of these **ARTICLES OF INCORPORATION**, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV - MEMBERS

Initial members of the Corporation shall be the Incorporators of the Corporation. Qualification of new members and the manner of their admission shall be as prescribed in the Bylaws.

ARTICLE V - DIRECTORS

The number of Directors shall not be less than five (5). The Directors shall be selected for the terms in the manner set forth in the Bylaws.

ARTICLE VI - OFFICERS

The affairs of the Corporation are to be managed by a President, a Vice President, a Secretary, a Treasurer, an Assistant Treasurer, and such other officers as may be deemed necessary by the BOARD OF DIRECTORS. Such officers shall be elected by the BOARD OF DIRECTORS at the first meeting of the BOARD OF DIRECTORS in the month of January of every year, and will have the functions and duties set forth in the Bylaws. The names of the officers who are to serve until wthe first election under these ARTICLES OF INCORPORATION are as follows:

ARTICLE VII - POWERS

1. The BOARD OF DIRECTORS shall have all the legal powers of this organization, specifically those granted and/or specify by the State of Florida Statutes for this type of not for profit entity, and all of those under which this Corporation may be considered subject to.
2. To do all and everything necessary, suitable and proper for the accomplishment of any and all the purposes of this organization.

ARTICLES OF INCORPORATION-ART.VII

3. Nothing herein contained shall be deemed to authorize this Corporation to engage in any activity or activities which are contrary to the State of Florida law on corporations not for profit.

ARTICLE VIII - BYLAWS

The BOARD OF DIRECTORS of this Corporation may provide such Bylaws for the conduct of its business and the carrying out of its purposes as it may deemed necessary from time to time.

The Bylaws may be altered, amended or replaced by the BOARD OF DIRECTORS by a majority vote of those present at any regular or special meeting of the BOARD.

ARTICLE IX - AMENDMENT TO ARTICLES

These ARTICLES OF INCORPORATION may be amended at a regular meeting of the BOARD OF DIRECTORS by a two-thirds majority vote of all BOARD members, provided written notice of intention to submit such amendment or amendments and a copy of those proposed amendment o amendments has been mailed to all BOARD members at least ten days prior to such a meeting.

ARTICLE X - OFFICE AND REGISTERED AGENT

The initial office of this Corporation is 390 N.W.2nd Street-Apt. 902-Miami, Florida 33128, and the registered agent is Manuel R. de Bustamante, at the same address.

ARTICLE XI - DISSOLUTION OF THE CORPORATION

Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for public purpose. Any such assets not so disposed of, shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes.

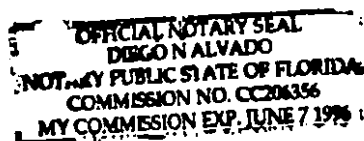
