ARTICLES OF INCORPORATION
OF
ORLAND BOYS HOME, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Orland Boys Home, Inc.

ARTICLE II

ADDRESS

The address of the principal office of the corporation is 200 East Robinson Street, Suite 500, Orlando, Florida 32806.

ARTICLE III

PURPOSE

The purpose for which the corporation is organized is to provide a therapeutic residential community-based program for boys designed to develop and accommodate independent living skills and prevent delinquency by diverting youths into positive rehabilitative modern growth and development.

ARTICLE IV

DIRECTORS

The method of election of the directors of the corporation is set forth in the By-Laws.

DISSOLUTION

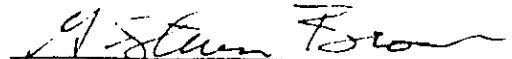

The corporation shall indemnify each officer and director, including former officers and directors, to the full extent permitted by law

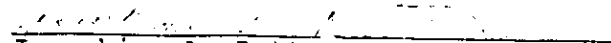
