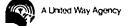

Articles of Incorporation of People to People, Inc.

FILED 95 JUN 17 FIL 3: 37

The undersigned, acting as incorporators of a corporation not for profit pursuant to Chapter 617, Florida Statutes, 1991, as amended, adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be "People to People, Inc."

# ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal office for the transaction of business of this corporation and the mailing address shall be 106 E. Church Street, Orlando, FL 32801.

## ARTICLE III - TERM OF EXISTENCE

The corporation shall exist perpetually.

#### ARTICLE IV - PURPOSES

The corporation is organized pursuant to the provisions of the general non-profit corporation law of the State of Florida.

The corporation is organized exclusively for religious, charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, or the corresponding provisions of any future United States Internal Revenue Law. Without limiting the foregoing, the express purposes of the Corporation are to assist at-risk families and individuals who are striving to become self-sufficient, by matching those with needs to those who have resources.

#### ARTICLE V - DIRECTORS

The affairs of the Corp ation shall be conducted and managed by a Board of Directors consisting of not less than three (3) members, as fixed from time to time by the By-Laws of the Corporation and Directors shall be elected or appointed in the manner provided in the By-Laws of the Corporation. The names and addresses of the initial Board of Directors who are to serve as Directors until the first meeting of the Corporation or until their successors are elected and qualified are:

# ARTICLE VI - MEMBERSHIP

This Corporation will be a non-membership corporation.

#### ARTICLE VII - POWERS

The Corporation shall have all the powers granted corporations not for profit under the Laws of the State of Florida; provided, notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of Section 501(c)(3) of the Internal Revenue Code of 1986, as it now exists and as it may be amended from time to time, or the corresponding provisions of any future United States Internal Revenue Law.

### ARTICLE VIII - DISTRIBUTION OF ASSETS UPON DISSOLUTION

In the event of the dissolution of the Corporation, the residual assets of the corporation remaining after payment of, or provision for payment of, all debts and liabilities of the corporation, shall be distributed to one or more organizations, which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended from time to time, or the corresponding provisions of any future United States Internal Revenue Law, exclusively to accomplish public purposes and none of the assets will be distributed to any member, director, officer, or trustee of this corporation.

# ARTICLE IX - AMENDMENT

The Corporation reserves the right to amend, alter, change, repeal and revise any of the provisions of this

Corporation's Articles of Incorporation in the manner now, or hereafter prescribed by statute.

# ARTICLE X - INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial registered office of the Corporation shall be 106 E. Church Street, Orlando, FL 32801, and the name of the initial registered agent at that address is Suzanne Lai.

### ARTICLE XI - INCORPORATOR
