ARTICLE V in the original was Authorized Membership Certificates; There are no Certificates in the Amended version.

ARTICLE V in Amended version is a restated version of original ARTICLE VI

ARTICLE VI in original (Management of Corp Affairs) included descriptions of Board of Directors and Officers

ARTICLE VI in Amended version describes the Officers of the Corporation

ARTICLE VII in both versions is Earnings and Activities of Corporation using nearly identical language.

ARTICLES VIII and XII of the orig are now combined into amended ARTICLE VIII-Dedication and Distribution of Assets

ARTICLE IX of original is subsumed into ARTICLE IV in amended (Members)

ARTICLE IX of amended includes the Original Incorporators from original ARTICLES VI and X.

ARTICLE X of original is subsumed into ARTICLE IX of amended.

ARTICLES XI and XIV of original Articles are restated as Article X in amended Articles.

ARTICLE XII of original is subsumed into ARTICLE VIII of Amended Articles.

ARTICLE XIII of original is restated as ARTICLE XI in Amended Articles.

ARTICLE XIV of original is restated in ARTICLE X in Amended Articles.

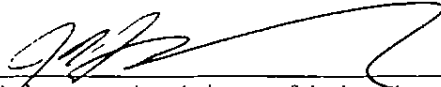
