ARTICLE ONE - NAME

The name of this corporation is PAC HOUSE, INC.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.

ARTICLE THREE - PURPOSE

The nature of the business, or objects or purpose to be transacted, promoted or carried on are:

To provide grassroot services to the community and in so doing, we will attempt to address the issues of: nutrition, health, housing, family counseling, education, juvenile crime, alternatives to incarceration, neighborhood recreation and some of the other ills that plague our communities.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the power of the corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no wise limited or restricted by any term or provision or any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object, expresses, and the enumeration as to specific powers, but are in furtherance of, and in addition to and not in limitation of said general powers.

ARTICLE FOUR - CAPITALIZATION

As a non profit entity there will be no shares distributed.

ARTICLE FIVE - REGISTERED OFFICE AND REGISTERED AGENT

The address of the corporation's registered agent is 6820 Benjamin Road, Tampa, Florida 33634, and the name of the corporation's registered agent at such address is Wanda Delite Casey.

The fiscal year of this corporation shall commence on January first and end on December 31-first.

The Board of Directors shall be elected in the manner set forth in the bylaws. In addition to the powers and authority granted to the directors in these Articles of Incorporation, and in addition to the powers and authority expressly conferred on them by statute, the Board of Directors of the corporation shall have such additional powers and authority, not inconsistent with law, as may be set forth in the bylaws. The presence of not less than twelve members shall constitute a quorum and shall be necessary to conduct the business of this organization. A lesser number may adjourn the meeting for a period of not more than two weeks from the date scheduled by the by-laws.

ARTICLE TEN - AMENDMENT

The corporation reserves the right to amend, add to, or repeal any provision contained in these Articles of Incorporation, in the manner consistent with law and in conformity with the provisions set forth in the bylaws.
