We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following;

#### ARTICLE I

The name of this corpor or ion is:

#### COMMUNITY HOUSING CORPORATION OF BROWARD

The principal place of business of this corporation shall be 9715 West Broward Blvd., #129, Plantation, Florida, 33324, and the mailing address of the corporation shall be the same.

#### ARTICLE II
