ARTICLES OF INCORPORATION

OF

THE PLANET ICE YOUTH HOCKEY ASSOCIATION OF THE PALM BEACHES, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is THE PLANET ICE YOUTH HOCKEY ASSOCIATION OF THE PALM BEACHES, INC., (hereinafter, "Corporation).

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly to organize and coordinate the Planet Ice youth travel hockey program. The players registered at Planet Ice who have demonstrated the highest skills and good sportmanship will be selected in the most fair manner to compete.
