The undersigned by these Articles associate themselves for the purpose of forming a corporation not for profit under Chapter 617 and 607 of the Florida Statutes and certify as follows:

Article One: Name

The name of the corporation shall be Wilawood Heights Neighborhood Association, Inc., hereinafter referred in this instrument as the "Association".

Article Two: Address

2.1 The address of the principal office and registered agent for the Association shall be;

2.2 The mailing address of the Association shall be:

Article Three: Purpose

- 3.1 The purpose of the Association is to enhance, improve, and beautify the Wildwood Heights Area of St. Petersburg, Florida, otherwise known by that certain geographic area described in the By-Laws.
- 3.2 The Association shall engage in those certain activities to accomplish these stated purposes.

Article Four: . "istence

The existence of the corporation is to be perpetual, and this existence shall commence on June 19, 1996, which shall be known as the effective date.

Article Five: Members

The Provision for qualification for members and the manner of their membership is provided for in Article Three of the By-Laws

Article Six: Manner of Election of Officers

- 6.1 The Officers shall be elected by the members of the Association in the manner as determined in Article Five of the By-Laws
- 6.2 At this time the Association does not have Board Members. When Board Members are elected it will be in the same manner as determined in Article Five of the By-Laws for the election of Officers.

Article Seven: Officers

- 9.2 Any amendment, alteration, or rescission may be further governed in the By-Laws.

- 10.3 At the next regular meeting of the Association following the one in which the amendment is proposed, the proposed amendment shall be adopted by seventy-five (75%) of the members present and eligible to vote at this Association meeting.
