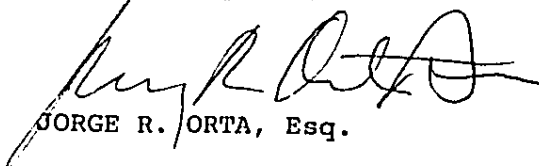

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of Florida, adopt the following articles of incorporation.

ARTICLE I

The name of the corporation is HURRICANE CHAPTER OF SOUTH FLORIDA, INC.

ARTICLE II

The corporation's duration shall be perpetual.

ARTICLE III

The purposes for which the corporation is organized are to engage in any activity permitted under the laws of the United States and in which a non-profit corporation in the State of Florida is permitted to engage.

ARTICLE IV

The qualifications for members and the manner of their admission shall be regulated by the by-laws.

ARTICLE V

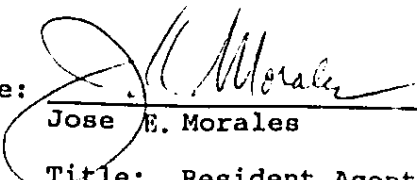

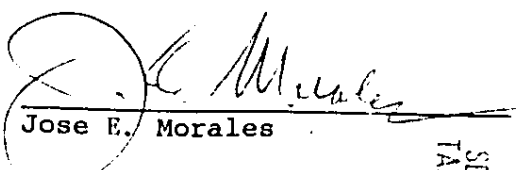
