The undersigned, acting as incorporator(s) of a corporation pursuant 617, Fiorida Statutes, adopt(s) the following Articles of Incorporation:

> ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

Section 1. The purpose for which this corporation is formed is exclusively charitable, educational and scientific and consists of formally developing a Community Development Corporation and:

A. To raise the economic, educational and social levels of the residents of the <u>Dade County</u> area and the surrounding counties, including members of the minority community, who are substantially unemployed, underemployed, or whose income is below federal poverty guidelines, to foster and to promote community-wide interest and concern for the problems of said residents to the end that: (see attachment page two) To shelter and serve the elder-ly and disabled in home care shelter and other related activities.

ARTICLE IV

Manner of election of directors The manner in which the directors are elected is as follows:

Section 1. The manner and procedure of all elections will be as they are outlined in the By-laws to this corporation.

- B. To expand opportunities available to said residents and groups to obtain adequate low-cost housing accommodations by construcing, rehabilitating, and providing decent, safe and sanitary housing and the target area(s), should this venture be undertaken, for persons and families of low-income who otherwise would not be able to find or to afford a suitable place to live. It is the purpose of the corporation thereby to secure the basic human needs of decent shelter and to promote the social welfare through this and other through other means commensurate with the goals and objectives of this corporation. To provide such housing rehabilitation of existing substandard buildings and cosnturction management of new facilities in the place of blighted structures of blighted vacant sites for the purpose of combatting the provement.
- C. To aid, support, and to assist by gifts, contributions, or otherwise, other corporation, community chest, funds and foundations organized and operated exclusively for charitable, educational or scientific purposes, no part of the net earnings of which inures to the benefit of any private shareholder, if there be any, or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.
- O. To do any an all lawful activities which amy be necessary, useful, or desirable for the furtherance, accomplishment, fostering, attaining of the foregoing pruposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, associations, trusts, institutions, foundations, or governmental bureaus, departments or agencies.
- E. All of the foregoi j purposes shall be exercised exclusively charitable and educational purposes in such a maner that the corporation will qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future Untied states Internal Revenue law.
- F. To aid in the correcting of past problems in credit histories, to aid clients in clearing their past credit problems through business and professional counseling and assistance in establishing proper credit habits and undertakings, to help clients qualify for business loans, to help students and others in financial aid planning for business and for educational institution admission, and to do all and related business assistance in preparing clients for business relations and positive business planning and personal enrichment.

### ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302,

Florida Statutes, unless limited or as follows:

Section 1. Any person who is authorized to make any public statement, whether written or oral, purporting to represent the official policy, position, recommendation or opinion of the corporation, shall first make it clear that he or she is representing the corporation. Thereafter, throughout the entire presentation, he or she shall confine his/her presentation only to those matters which have been properly approved by the corporation.

Section 2. He or she shall not, on this subject, at the same time present any statement(s) purporting to represent his or her own personal views.
