The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I: NAME

The name of the corporation is **The Keys Academy of Marine Science, Inc.**

## ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 141 Aregood Lane, Islamorada, FL 33036.

## ARTICLE III: PURPOSE

Pursuant to F.S. 617, This Corporation is organized for the purpose of establishing and maintaining a non-profit private educational institution.

## ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

### **ARTICLE X: AMENDMENTS**

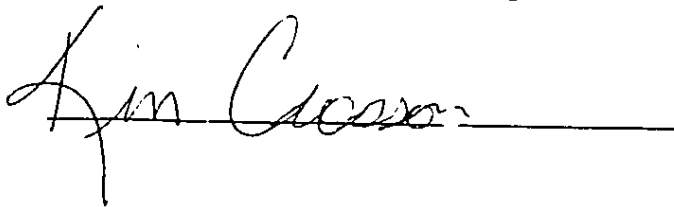
The corporation reserve the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
