**ARTICLES OF INCORPORATION
OF
MOLINO FIRST ASSEMBLE OF GOD/PUGH'S CHAPEL CHURCH, INC.**

We the undersigned, acting as incorporator(s) of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be Molino First Assemble of God/Pugh's Chapel Church, Inc.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be 3436 Molino Road, Molino, Florida 32577.

ARTICLE III

Purposes

The purposes, general nature and the object of this corporation are as follows:

1. To buy, purchase, own, or acquire by gift, devise, purchase or otherwise, real and personal property, and to build, erect, construct, provide for, maintain and equip suitable building, churches, houses, etc., for the benefit, use and occupation of the Molino first Assembly of God/Pugh's Chapel Church, Inc., its members and congregation, and for all other meetings and purposes of the Molino First Assembly of god/Pugh's Chapel Church, Inc., its members and congregation.
2. To build, construct, erect, maintain and equip schools, mission stations, and mission churches, pastor's homes and such other homes or equipment as the church may desire for carrying on its work.
3. To receive, administer, disburse and invest gifts, devices, and bequests by or from any person or corporation.
4. To issue bonds, notes, debentures and evidence of indebtedness, and to secure the same by mortgage, deed of trust or otherwise.
5. This corporation is organized primarily for the purpose of holding the title of such property or properties as the said Molino First Assemble of God Church, Inc., shall from time to time purchase or acquire and it shall have power, form time to time, to make such contracts and to do such things as shall be authorized and directed by the members of the said Molino first Assembly of God Church, Inc.

ARTICLE IV

Election of Directors

ARTICLE V
Limitation of Powers

This corporation shall possess all the rights and privileges and immunities, and enjoy all the benefits granted to a corporation of similar character under the Law of the State of Florida. The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, and shall be limited as follows:

Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from the Federal Income Tax under Section 501(a)(3) of the Internal Revenue Code, or the corresponding provisions of any future United States Internal Revenue code or by a corporation contributions of which are deductible under Section 170(c)(2) of the Internal Revenue Code or any other corresponding provisions of any future United States Internal Revenue Code revisions.

ARTICLE VI
