ARTICLES OF INCORPORATION OF

AJENE ENTERPRISES INCORPORATED A FLORIDA NONPROFIT CORPORATION

Article I. Name. Ajene Enterprises Inc.

Article 2. Duration: The duration of the Corporation is perpetual

Article 3, Purpose: The purpose of the corporation is as follows:

A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation is dedication to decreasing the unemployment rate of American college students nationwide by offering the most effective method of linking employers to students utilizing the Information Super Highway and by educating the communities about the Information Super Highway The corporation will not engage in any of the following activities:

- lending funds without adequate security or interest payments;

- paying members of offers unreasonable compensation for view services;
- making organizational services available to preferred persons;
- buying substantial amounts of securities or property at unrecallable prices.
- selling a substantial part of its own securities, or other propen for less than fair market value; or
- any other business activity that substantially diverts the corporate income.
- B. To exercise all rights and powers conferred by the law of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net carnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members: The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, be admitted in such manner and who shall have such rights and privileges as set forth in the Bylaws, but who shall not have the right to vote.
