#### EXHIBIT "A'

That ARTICLE III of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

## "ARTICLE III - PURPOSE

The Corporation is organized exclusively to teach African-American culture, music, dance, arts, customs, traditions, language or history, or exclusively to operate as an educational, scientific, religious or charitable organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954, as amended."

That Article XI is hereby added to the Articles of Incorporation of the Corporation to read as follows:

## "ARTICLE XI - INDEMNIFICATION

The Corporation shall indemnify its officers, directors, employees or agents in those cases as now or hereafter provided in Sections 617.0831 and 617.0834, Florida Statutes."
