ARTICLES OF INCORPORATION

<u>of</u>

(A Corporation Not For Profit)

I, the undersigned incorporator, make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be CHRISTIAN FAMILY CHURCH, INC., and the residence and mailing address shall be 14920 Triton Terrace, Hudson, Florida 34667.

ARTICLE II - PURPOSE

a) This corporation is organized and shall be operated exclusively for charitable, religious, educational and scientific purposes, including, among other things, educational purposes related to services to the needy, and the methods and tools used to accomplish same. As a means for establish and maintain charitable, educational be within the purposes of this corporation to and institutions, and the aid of such activities, agencies, and institutions already established members or directors and which shall further the purpose of this corporation.
