ARTICLES OF INCORPORATION
OF
STAND AGAINST VIOLENT ENERGY (SAVE) INCORPORATED
A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is : Stand Against Violent Energy (SAVE), Incorporated

Article 2. Duration: The duration of the Corporation is perpetual.

Article 3. Purpose: The purpose of the corporation is as follows:

A. This corporation is a not-for-profit charitable outreach ministry corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation are 1). to reduce the violent acts people commit against others and establish a base of new understanding of each other 2). to reduce the number of addicted (drugs and alcohol) people 3). to provide job opportunities for individuals who become clean and/or released from incarceration and 4). to become a 501(c)(3) status organization by the IRS.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon a nonprofit corporation.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members: The Corporation shall have non voting members only.

Article 5. Initial Registered Agent and Office. The initial registered agent is Lenord Dexter and initial registered office is 1107 Tuskawilla Drive # 3, Clearwater, Florida 34616.

Article 6. Initial Board of Directors. The initial Board of Directors shall have 3 members whose names and addresses are:

Article 7. Officers. The officers of the Corporation Shall consist of President, Vice President/Secretary, and Treasurer. Other officers may be provided for in the Bylaws. The President, Vice President/Secretary, and Treasurer shall remain in office until a written notice of termination is received by the Board of directors. The other officers will be elected and voted on the board by the President, Vice President/Secretary, and Treasurer. The Bylaws shall prescribe the duties and powers and manner of election of the officers and directors.

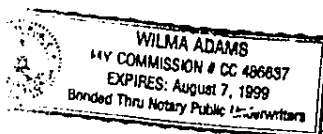
