
Gentlemen:

Attach please find the application for reinstatement for the above two not-for-profit corporations, along with checks for \$61.25 for each entity. The purpose of this letter, is to request that the reinstatement fee of \$175.00 for each corporation be waived. The reason for this request, is that the former party handling the registration for the corporations, passed on this year, and the clubs were unaware that the annual registration was not filed. Both of the corporations are for the youth of our community, and many of the participants are scholarshipped, with funds coming from private donations and fund raising.
