## ARTICLUS OF INCORPORATION

The undersigned, acting as incorporators of a corporation, pursuant to Chapter 617. Florida Statutes adopt the following Articles of Incorporation:

#### ARTICLE 1

The name of the corporation shall be:

The Sarasota Bradenton Children's Zoo, Inc. A Florida Non-Profit Corporation

The Corporation shall have succession by its corporate name for a period set forth as: in perpetuity.

## ARTICLE II

Principal place of business and mailing address of this corporation shall be:

#### ARTICLE III

#### Purposes

The specific purposes for which the corporation is organized are: , Inc.

The Sarasota Bradenton Children's Zoo, A Florida Non-Profit Corporation, hereafter referred to as the Corporation, a nonprofit corporation, is organized promote harmony between people, and the natural environment. As such, its seeks to establish and maintain a home for wildlife in need and an educational center which balance the needs of people and the needs of and animal systems in which people live. The Corporation's purposes are scientific, and charitable. rehabilitative, educational zoological. Its mission is to thoughtfully educate youth as to the needs, and habits of wildlife, protect and rehabilitate wild animals and, whenever possible, return them to the wild. The Corporation maintains a strong commitment to conservation. education, the saving of threatened species and ecosystems and the land and waters they need to survive.

# ARTICLE IV

Manner of election of Directors

The manner in which the directors are elected or appointed is as follows:

For the purposes of this document Directors shall be defined Trustees and the Board of Directors shall be held as synonymous with Board of Trustees. The number of persons on the Board of Directors of The Gulf Coast Sanctuary - A Florida Non-Profit Corporation, shall be a minimum of three and a maximum of eleven and always an odd number. Membership to the Board of Directors (Trustees) shall be for a minimum of two years. Elections to the Board of Directors (Trustees) shall be held every two years on the first Saturday of January , unless otherwise decided by a two thirds majority of the Board. At an election of Directors (Trustees), every general member who, in the opinion of the Board, has shown commitment to the Corporation's goals through financial contribution, physically or educational effort or in another substantial manners for a period of two years will be entitled to one vote, in person or in proxy for as many slots as there are Directors (Trustees) to be elected. All nominations from the general membership will be placed in nomination and the candidate(s) receiving the most votes will fill the Board's vacancy(ies). If the number of votes tie for two or more candidates for the last slot vacant, selection for that slot will be by lot. Decisions of administration will be made by the Board by a simple majority vote. Decisions of policy will require a two-thirds vote.

Members of the Board of Directors (Trustees) shall meet all qualifications for general membership in the Corporation. If a Board Member resigns or is disqualified from general membership, his/her membership on the Board will likewise terminate concurrently, provided that should the number of Directors (Trustees) ever fall below the number required by law, a new Director (Trustee) shall be immediately appointed by the remaining members of the Board to serve until confirmed or teplaced at the next general meeting.

## ARTICLE A

## limitations of corporate powers

The corporate powers of this corporation are as provided in scriting (17.0302). Florida statutes, but further limited a tellory:

- 1) the corporation shall not have the power to allow compensation to any member of the board of Derectors (Trustees) beyond the token sum of twenty five dollars (\$25.00) in addition to expenses incurred by any member in behalf of the Corporation
- The Corporation shall not have the power to issue bonds, notes, or other obligations and secure any of its obligations by mortgage or pledge of its property, franchises or income.
- The Corporation shall not have the power to alter the common corporate seal or logo which shall always contain the words 'corporation not for profit" without unanimous consent of the Board of Directors
- The Corporation shall not have the power to make loans of any nature to its Directors (Trustees), officers or employees or to any other firms, co.porations, associations of entitie, in which one or more of its directors, officers or employees holds any financial interest.
- officers and Direction (Trustees) of the Corporation shall not be personally or communally libel for monetary or other damages to any person, jurisdiction or entity for any statement, vote, decision, action, or failure to take an action regarding organizational management, policy or action of the Corporation
