## ARTICLES OF INCORPORATION OF THE SARASOTA BRADENTON CHILDREN'S ZOO, INC.

## A.K.A. GULF COAST SANCTUARY

# AS AMENDED THIS THE DAY OF May 2,000

Articles of Incorporation of the undersigned, a majority of whom, are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Organization shall be Gulf Coast Sanctuary/Sarasota Bradenton Children's Zoo, Inc.

Second: The place in this state where the principal office of the Organization is to be located is the City of Sarasota in the County of Manatee. (ie 7512 N. Tamiami Trail, Sarasota 34243)

Third: Said Corporation is organized exclusively for charitable, educational, and community service, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Fourth: The names and addresses of the persons who are the initial trustees/Board of directors of the Corporation were as follows:

Their signatures appear on the last page of this document. However. Movement out of the state and other commitments and ailments have caused the majority to cease to be active in the Corporation. Therefore, this meeting was called to amend these Articles for the Benefit of the SBCZ/GCS

Fifth: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons other than trustees, employees, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions, all at the discretion of the Director of Operations in the sole furtherance of the purposes set forth in Third Article hereof. No substantial part of the activities of the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organizationn, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the Organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public charitable purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
