The undersigned incorporators have executed these Articles of Incorporation for the purpose of forming a Honprofit corporation under the laws of the State of Florida, in accordance with the following provisions:

ARTICLE I

The name of the Corporation shall be: THE REALITY FOUNDATION, INC.

ARTICLE II

The Corporation is organized pursuant to the laws of the State of Florida.

ARTICLE III

The Corporation shall exist perpetually.

ARTICLE IV

The Corporation is formed for the following purposes:

- A. Exclusively for charitable purposes;, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. Lessening the burden of government by, without limitation, making monetary contributions to the Treasury of the United States of America, thereby reducing, and ultimately, retiring the National Debt of the United States of America.
- C. Making available the results of nonpartisan analysis, study, or research; specifically, without limitation, making available the results of nonpartisan analysis, study or research regarding the National Debt of the Federal Government of the United States of America.
- D. Examining and discussing broad social, economic and similar problems, specifically, without limitation, examining and discussing the National Debt of the Federal Government of the United States of America.

- E. To influence legislation (including "lobbying" as the term lobbying is described in Publication 557 of the Internal Revenue Service, revision dated January, 1995), subject to the 1996 spending limit of the lesser of (i) One Million (\$1,000,000) Dollars; or (ii) five (5%) per cent to twenty (20%) per cent of exempt purpose expenditures; or the maximum such expenditures allowable by the Internal Revenue Code, Rules and Regulations in the future.
- F. To influence legislation via "grass roots" expenditures, as the term grass roots is defined in Publication 557 of the Internal Revenue Service of the United States of America, revision dated January, 1995, as amended in the future; subject to the 1996 spending limits of twenty five (25%) per cent of the lobbying non-taxable amount; or the maximum such expenditures allowable by the Internal Revenue Service in the future.
- G. To do any and all things incident thereto.

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office, EXCEPT that the Corporation shall be allowed to carry on propaganda, and shall be allowed to otherwise attempt to influence legislation, and the corporation shall be authorized to participate in, and intervene in (including publishing or distribution of statements) any political campaign, all to the extent authorized by Federal Law, Rule and Regulation now in effect, or the corresponding section of any future federal tax Law, Rule or Regulation. Specifically, the Corporation shall adhere strictly to spending limits then in effect regarding attempts to influence legislation.

Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers not in furtherance of the purposes of this corporation.

ARTICLE VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 [c] (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, as determined by a majority of the then directors of the corporation at the time of corporate dissolution. Any assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
