

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
ESCAROSA REGIONAL WORKFORCE DEVELOPMENT BOARD, INC.,  
a Florida corporation, not for profit**

1. The name of the Corporation currently is Escarosa Regional Workforce Development Board, Inc.

2. The Articles of Incorporation are amended to change the name of the Corporation as follows:
