In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit business corporation to engage in the business of organizing, supervising, and administering the amateur golf activities in Highlands County, Florida.

ARTICLE I

The name of the corporation ("Corporation") is HIGHLANDS COUNTY AMATEUR GOLF ASSOCIATION, INC.

ARTICLE II

The existence of the corporation shall begin on the 1ST day of July, 1996.

ARTICLE III

The street address of the principal office of the Corporation is 14 South Lake Avenue, Avon Park, Florida 33825.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
