The undersigned acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

ARTICLE I

The name of the Corporation shall be;

FIRST BAPTIST CHURCH OF CROSS CITY, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: U.S. highway 19 North, P.O. Box 897, Cross City, Florida 32628

ARTICLE III

The purpose of this corporation is the coming together of the members of the corporation to worship God. This corporation is organized exclusively for religious and charitable purposes. This corporation is a non-profit, non political organization and is not organized or incorporated for pecuniary profit. No part of the income of the corporation is distributable to its members, directors or officers and no part of the net earnings of the corporation shall inure to the benefit of any private shareholder. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows: In accordance with the By-Laws adopted by First Baptist Church of Cross City, Inc.
