WE, the undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together in order to form a CORPORATION NOT FOR PROFIT under the provisions of § 617 of the Florida Statutes, with all the powers, rights, privileges, and immunities; and to that end we do, by these Articles, set forth:

ARTICLE I - NAME, ADDRESS AND AGENT

The name of this corporation shall be: "PARTIDO ORTODOXO CUBANO, INC" (hereinafter referred to as "the corporation"). Its Registered Office shall be located at 2730 S.W. 19th. Terrace, MIAMI, FLORIDA 33145.- and its Registered Agent shall be Dr. Luis CONTE-AGUERO
