ARTICLES OF INCORPORATION

OF

FARMS ROAD COMMUNITY ASSOCIATION TINE.

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is FARMS ROAD COMMUNITY ASSOCIATION, INC.

ARTICLE II: PRINCIPAL OFFICE
