ARTICLES OF INCORPORATION

In compliance with the requirements of the Laws of the State of Florida, the undersigned hereby associate themselves together for the purpose of forming a religious corporation not for profit and do hereby adopt the following articles of incorporation:

ARTICLE I
NAME

The name of the religious corporation is OPEN DOOR BIBLE CHURCH, INC., hereinafter sometimes referred to as "religious corporation" or "Church":

ARTICLE II
STATUS

The corporation is a nonprofit religious corporation.

ARTICLE III
AUTHORIZATION

The religious corporation shall be governed by and proceed under the laws of the State of Florida.

ARTICLE IV
PURPOSE

This religious corporation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, print shops, day care centers, camps, nursing homes, and cemeteries, and any other ministries that the Church may be led of God to establish.

The Church shall also ordain and license men to the Gospel ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; maintain missionary activities in the United States and any foreign country; and engage in any other ministry that the Church may decide, from time to time, to pursue in obedience to the will of God.

ARTICLE V
PLACE OF WORSHIP

The post office address of the religious corporation's principal office and place of worship is 3373 Confetti Lane, Pompano Beach, 33063, County of Broward, State of Florida.

ARTICLE VI
DURATION

The period of duration of this religious corporation is perpetual.

ARTICLE VII
NONSTOCK CORPORATION

This religious corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE VIII
TRUSTEES/DIRECTORS

The number of individuals constituting the initial board of trustees/directors of the religious corporation is three (3), and the names and addresses of the persons who are to serve as the initial trustees/directors are as follows:

ARTICLE XI ELECTION OF OFFICERS

The officers shall be elected by the trustees/directors as set forth in the religious corporation By-Laws.

ARTICLE XII MEMBERSHIP REQUIREMENTS

The method and conditions on which members shall be accepted, transferred, discharged, and removed shall be as set forth in the religious corporation By-Laws.

ARTICLE XIII AMENDMENTS

These articles may be amended in the manner provided by statute or as set forth in the By-Laws of the religious corporation.

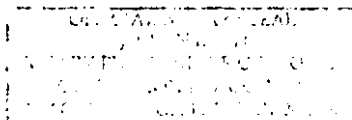
