ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - Name

The name of the Corporation shall be:

ARTICLE II - Principal place of business and mailing address

ARTICLE III - Purposes

The specific purposes for which the Corporation is organized are:

To work for the protection of the clean air, clean water and all the other elements of our natural heritage in the north central region of the State of Florida; to work to prevent the degradation of our air and water from contamination and other misuse; to work to conserve our intact natural heritage; to provide information to the public and to pursue other educational activities; and to engage in any other legal business activities permissible under Chapter 617, Florida Statutes.

ARTICLE IV. - Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

The number of Directors of the Corporation, and the method of their election or appointment, shall be stated in the Bylaws of THE CORPORATION FOR CLEAN AIR AND CLEAN WATER, INC.

ARTICLE V. - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE X - Dedication of assets

In the event of dissolution of this corporation, the residual assets of the organization will be turned over by the Board of Directors to one or more organizations which are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the *Internal Revenue Code* of 1954 or the corresponding sections of any prior or future laws.

ARTICLE XI - Indemnifications

The Corporation shall indemnify and hold harmless the Officers and Directors of this Corporation from and against any and all cause and causes of action, liabilities, losses and damages of any kind or nature, including any reasonable attorney's fees and expenses incurred in connection with the execution of their duties or the exercise of their discretion taken on behalf of the Corporation, except when the same is judicially determined to be due to the gross negligence or willful misconduct of such persons. Nevertheless, the Corporation shall be given reasonable notice by such persons of any such action and be given reasonable opportunity to assume the defense against the same and to indemnify and hold harmless said persons therefrom.
