ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION

APOSTLE FAITH CHURCH OF MIRACLES, INC

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

Article III.

The purpose for which the corporation is organized is (are): This is a non-stock, non-profit corporation. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
