ARTICLES OF INCORPORATION OF FIRST CITY OF REFUGE, INC.

Article 1. Name. The name of the Corporation is: First City of Refuge, Inc.

Article 2. Duration The duration of First City of Refuge, Inc. is perpetual

Article 3. Purposes. The purpose of First City of Refuge, Inc. is as follows:

- A. First City of Refuge is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to conduct any lawful business not for pecuniary profit and not specifically prohibited to corporations under the Florida Statutes.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that **First City of Refuge, Inc.** shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of **First City of Refuge, Inc.** shall inure to the benefit of or be distributable to its members, directors, or officers; but **First City of Refuge, Inc.** shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
- Article 4. Members. First City of Refuge, Inc. shall have no Voting Members. The Bylaws may provide for Nonvoting Members, of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
- Article 5. Initial Registered Agent and Office. The initial registered agent is Sylna Rego and the initial registered office 840 S. Park Rd. #5-21. Hollywood, Fl. 33021.

Article 6. Initial Board of Directors. The initial Board of Directors shall have <u>7</u> members whose names and addresses are:
