Manner in which Directors are elected or appointed:

Section 1.

The Board of Directors shall consist of 3 members to hold office for 3 years. Each member shall be elected by ballot at the general meeting every 3 years.

Section 2.

All candidates for election to the Board of Directors shall be nominated by a committee of no more than 4 members appointed by the president. Said candidates to be elected or appointed according to the By-laws of this corporation.
