ARTICLES OF INCORPORATION
OF
RAMATA, INC.
A NONPROFIT CORPORATION

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

RAMATA, INC.

The address of the principal office of this corporation shall be P.O. Drawer 60205, Fort Myers, Florida 33906, and the mailing address of the corporation shall be the same.

ARTICLE II.

The general purpose of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is to directly or indirectly accept contributions or make expenditures for all activities that are directly related to and support the process of influencing or attempting to influence the selection, nomination, election or appointment of any individual to public office or office in a political organization.

ARTICLE III.

The manner in which the directors are to be elected or appointed is as stated in the bylaws.

ARTICLE IV. DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation. 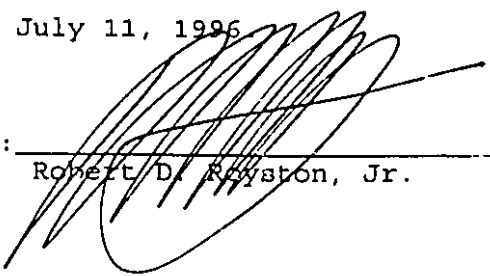
