Enclosed please find the completed 1996 Annual Report for the above-referenced corporation together with the applicable fee.

As you may recall from our discussion, this corporation was erroneously listed as a profit corporation in the records maintained by the Division of Corporations. The corporation has 501(c)(3) status currently and had such status during 1994 and 1995 as well. Consequently, the corporation was eligible to pay the not for profit annual report fee during those years and, because the for profit fee was actually paid, we are requesting a refund of the excess payment for those years. As we discussed, the refund for 1994 should be \$163.75 and \$68.75 for 1995.
