ARTICLES OF INCORPORATION
OF
FIRST FULL GOSPEL CHURCH OF WEST PALM BEACH, INC.

ARTICLE I: CORPORATE NAME

The name of this not for Profit Corporation shall be the
FIRST FULL GOSPEL CHURCH OF WEST PALM BEACH, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

This not for Profit Corporation is organized for the
specific purpose of the operation of a Church, and Church related
activities.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed
is as follows:

- a. The initial incorporator(s) shall appoint the initial
Board of Directors, consisting of three (3)
individuals.

- b. Directors shall serve a term of three (3) years, such expiration coinciding with the date of the Annual Directors' Meeting.
- c. Upon the expiration of the term of the Board of Directors, such directors, prior to the expiration of their term, shall be quorum vote, elect the incumbent Board.

ARTICLE V: LIMITATION OF CORPORATE POWERS

The corporate powers of this Corporation are as provided in Section 617.0302, Florida Statutes.




