## **ARTICLE I**

#### NAME

The name of the Corporation is Compeer Community Outreach, Inc.

## **ARTICLE II**

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

## ARTICLE III

### **PURPOSE**
